## Oakland City Elementary Title I Parent Involvement Policy

## **Goals of Parental Involvement**

  - B. Explanation of grade level content standards
  - C. Data tracking to measure student progress (ILEARN, IREAD-3, Dibels, Star, Report Cards)
  - D. Student progress monitoring sent home through progress reports
  - E. Opportunities for discussion related to the education of their child via conferences, phone calls, emails, Remind messaging, reports, etc.
  - F. Materials sent home concerning how parents can improve their child's achievement
  - G. Information directly sent home through School Messenger phone calls, School website, flyers, etc. in language that parents can understand
  - H. Viewing grade and attendance records on Harmony
  - I. Encouraging involvement in the Parent-Teacher Organization
- 4) Promote parental involvement strategies under Title I through programs such as Head Start, school Pre-K program, and other instructional programs, such as Kindergarten Round-up.
- 5) Through parent/guardian surveys or parent groups, Oakland City Elementary and East Gibson School Corporation will conduct an annual (fall semester) evaluation of Parental Involvement Policy at Oakland City Elementary. These survey and groups will help identify the involvement of parents, particularly focusing in on students who are economically disadvantaged, disabled, have limited literacy, limited English proficiency, or any racial or ethnic minority background. These findings will allow

Oakland City Elementary to develop strategies to increase parental involvement.
