- 6. Francisco Elementary School will promote our local Head Start Programs and offers testing for kindergarten readiness.
- 7. Ongoing professional development will take place during staff meetings, on professional development days, and after school to help staff with best practice techniques for parental involvement. It is the intent of the staff to develop supportive relationships with our student's parents.
